## Usine de production d'eau à cycle complet avec un processus automatisé maximal

L'eau potable est produite à l'aide d'un système de filtration par osmose inverse (OI), un système de filtration utilisant une membrane spéciale. Également connue sous le nom de membrane, elle est fabriquée à partir de fibres cellulosiques synthétiques avec une résolution de 0,0001 micron, ce qui est plus petit qu'un cheveu. Grâce à cette propriété, la solution de contaminants tels que les métaux lourds, les engrais chimiques, les pesticides, le plomb et divers agents pathogènes qui sont plus gros ne peuvent pas pénétrer à travers cette membrane filtrante. Seules les mèches pures peuvent pénétrer.

Les contaminants piégés dans le média filtrant sont immédiatement éliminés du système afin d'éviter toute accumulation à l'intérieur de l'unité en les séparant de l'eau pure filtrée. Cette méthode permet de filtrer l'eau RO.
