Un nouveau centre de distribution de gros sera créé pour servir de plaque tournante pour l'exécution des commandes et les livraisons sur le dernier kilomètre.

Enfin, des investissements sont recherchés pour mettre en place un canal de vente en ligne et les intégrations correspondantes de la chaîne d'approvisionnement. Cela permettra à notre portefeuille d'articles de volaille, d'œufs et de viande d'être listés et achetés directement sur les places de marché et les plateformes de commerce électronique utilisées par les principaux supermarchés et hypermarchés.

Globalement, cette expansion vise à positionner l'entreprise comme l'un des principaux fournisseurs de services entièrement intégrés verticalement dans la région.
