L'application iOS, leader sur le marché, qui permet de scanner et de décoder les codes QR de manière rapide et fiable, est disponible à l'acquisition. Elle compte 2,9 millions d'utilisateurs actifs mensuels et plus de 70 millions de téléchargements au total. Il s'agit d'une application polyvalente de scanner de codes QR et de codes-barres prenant en charge plus de 15 types de codes. Il offre des fonctionnalités telles que des informations détaillées sur les produits et les aliments, un historique de numérisation, des dossiers organisés, la numérisation par lots et l'exportation CSV. L'application est multiplateforme (disponible sur iPhone, iPad et Mac avec Apple Silicon).

L'application fonctionne sur un modèle freemium, offrant un abonnement pro pour des scans illimités, l'accès à des informations sur les produits et une expérience sans publicité. 70 % des recettes proviennent des abonnements et de l'IAP et 30 % de la publicité. 833K\$ MRR et 9M\$ ARR.
