Les principales activités et responsabilités d'un trustee agréé par la FINMA sont les suivantes :

- **Gestion des actifs:** Le fiduciaire gère et dispose des actifs de la fiducie conformément aux termes de la fiducie et aux obligations légales.
- **Obligation fiduciaire :** le fiduciaire a l'obligation légale et fiduciaire d'agir au mieux des intérêts des bénéficiaires.
- **Opérations commerciales:** Une entreprise est considérée comme une fiduciaire commerciale si elle génère plus de 50 000 francs suisses par an ou si elle gère des fonds fiduciaires d'une valeur supérieure à 5 millions de francs suisses, entre autres critères.
- **Exigences organisationnelles:** L'entreprise doit disposer d'une organisation appropriée, y compris d'une gestion des risques et de contrôles internes adéquats, et sa direction effective doit se trouver en Suisse.
- **Qualifications professionnelles:** Les personnes chargées de la gestion et de l'administration doivent posséder les qualifications professionnelles nécessaires et jouir d'une bonne réputation.
