Il s'agit d'une proposition de centrale solaire photovoltaïque (PV) à grande échelle située à Crotona, une municipalité de Calabre, en Italie.

Le projet est de taille importante, avec une capacité de pointe de **6 MWp (6 000 kW) et de 2 MWp (2 000 kW)**. Cette capacité est conçue pour produire une quantité importante d'électricité propre et renouvelable, contribuant ainsi de manière significative à l'approvisionnement régional en électricité et soutenant la transition de l'Italie vers des sources d'énergie durables. La centrale est conçue pour offrir de hautes performances, en utilisant des technologies de pointe telles que les **suiveurs monoaxiaux** pour maximiser la récolte d'énergie en suivant le mouvement du soleil tout au long de la journée.

Le développement de cette nouvelle source d'énergie passe par les étapes réglementaires nécessaires et a récemment reçu une **validation positive de la conception définitive du projet**, ce qui constitue une étape clé vers sa construction, son exploitation et sa connexion au réseau électrique national.
