La propriété est entièrement équipée d'installations équestres de première qualité, notamment un marcheur pouvant accueillir jusqu'à 8 chevaux, un rond de longe, des arènes extérieures professionnelles et un manège couvert adapté aux compétitions internationales. Ce haras historique a fait l'objet d'une rénovation approfondie et d'une remise à niveau complète, alliant son caractère traditionnel aux technologies modernes les plus récentes.

Situation et cadre

Située dans l'une des régions les plus dynamiques d'Europe sur le plan économique, la propriété bénéficie de la proximité immédiate d'aéroports internationaux, d'universités de premier plan et de grands centres métropolitains. Le domaine offre un rare équilibre entre intimité et accessibilité – entouré de paysages naturels préservés tout en restant parfaitement connecté à la vie urbaine.
