Jusqu'au mois de juin de cette année, elle ne négociait qu'à la Bourse de Chittagong (CSE), qui ne détient que 3 % du marché boursier du Bangladesh, les 97 % restants étant négociés à la Bourse de Dacca.

- Récemment, l'entreprise a acheté la licence et a commencé à négocier à la Bourse de Dhaka, de sorte que le bénéfice indiqué ci-dessous devrait tripler à partir de cette année, le commerce des produits dérivés commençant également cette année.
- Elle connaît une croissance intense et, avec le début de la commercialisation des produits nouvellement introduits, l'entreprise affichera un taux de croissance significatif.
- Lors de ses transactions à la bourse de Chittagong, l'entreprise a toujours occupé la première ou la deuxième place en termes de chiffre d'affaires.
- Le chiffre d'affaires prévisionnel de l'entreprise devrait tripler avec l'introduction de la négociation à la bourse de Dhaka et des produits dérivés.
- La société dispose de plusieurs modèles de revenus, notamment les commissions perçues lors de l'achat et de la vente de produits de base, les frais de maintenance, les frais d'introduction en bourse et les frais de service.
- Il s'agit d'une entreprise familiale qui appartient à 100 % à la famille.
