L'entreprise a construit et développé son logiciel principal sous la direction de l'un de ses partenaires, qui possède une expérience considérable en matière de programmation tout en utilisant son expertise et les dernières technologies à chaque étape du développement, depuis sa création en 2006 jusqu'à aujourd'hui.

Le produit a prouvé son succès face à ses concurrents sur le marché où les nouveaux clients l'ont préféré à d'autres logiciels pour ses nombreux avantages distinctifs.
